## ISSUE PRICE OF NEW UNITS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN

ESR Funds Management (S) Limited, as manager of ESR-REIT (the “**Manager**”) wishes to announce that the issue price of the new units in ESR-REIT pursuant to the application of the Distribution Reinvestment Plan to ESR-REIT’s distribution for the quarter ended 30 June 2017 (“DRP Units”) is S\$0.5713 per DRP Unit.

The issue price represents a discount of 2% to the volume-weighted average traded price per unit in ESR-REIT (“Unit”) on the Singapore Exchange Securities Trading Limited (the “SGX-ST”) from 19 July 2017 to 21 July 2017 (both dates inclusive).
